The North Eastern Regional Institute of Water and Land Management (NERIWALM) was established at Tezpur, Assam by North Eastern Council (NEC), in December, 1989 when NEC was under the Ministry of Home Affairs, Govt. of India. The Institute's was registered under Society Registration Act, XXI of 1860. After signing a tripartite agreement in the form of a Memorandum of Understanding between the Ministry of Water Resources, River Development and Ganga Rejuvenation (MoWR, RD &GR), Govt. of India, Ministry of Development of North Eastern Region (DoNER), Govt. of India and NEC, the Institute was transferred to MoWR, RD & GR, Govt. of India with effect from 1st April, 2012. Since then the Institute is under the administrative control of MoWR, RD & GR, Govt. of India. The Institute is situated in 3 km away from the historically famous town of Tezpur, Sonitpur district of Assam and located on the north bank of river Brahmaputra at about 180 km from Guwahati. It is connected by road, rail and air with other parts of the country.

NERIWALM invites application for admission in Post Graduate Degree (M.Tech.) in Water Resource Management, for the session 2021-22. Eligible Candidates may apply through NERIWALM Entrance Examination (NERIWALM-EE-2021). The duration of Degree is two years and requires successful completion of 68 credits, as laid down by Assam Science and Technology University, Guwahati. M.Tech. (WRM) programme further requires the completion of dissertation on theoretical or a field problem as per the requirements of ASTU, Guwahati. It normally takes 24 months of time if completed on full time basis.

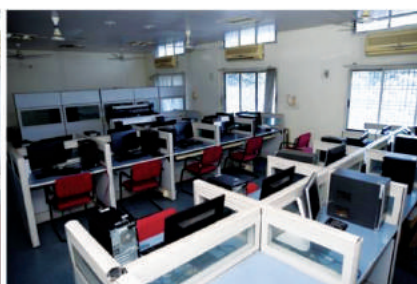

## ADMISSION

Admission Procedure/Eligibility criteria

1. Language of instruction : English
2. Approved Intake : 18(Eighteen) on full time

### 3. ELIGIBILITY FOR ADMISSION

Candidates with any of the following academic qualifications are eligible to apply for admission to M.Tech. programme in Water Resources Management:

BE/B.Tech/AMIE in Civil/ Agricultural Engineering with a minimum of 50 % marks (45% for ST and SC) in aggregate (or equivalent CGPA), Candidates awaiting for last semester BE/B.Tech/AMIE results in the above mentioned branches may also apply, but will have to submit the required documents within a stipulated period to be specified by the selection committee.

#### For full time sponsored/nominated candidates only:

(i) Candidates seeking admission to M.Tech. and who possess the required qualification (s) stated above must have at least 50 % marks (45% for ST and SC) at qualifying degree level. *The SC/ST category candidates must submit, the requisite certificate along with the application / or at the time of counseling (for GATE qualified/fresh candidates) from a competent authority.*

(ii) The full-time sponsored candidates must have a minimum of two years of full-time work experience in responsible capacity in a Registered Firm/Company/Industry/Educational and Research Institution/Govt./Quasi Govt. Autonomous Organization in the relevant field in which admission is being sought. The Firm/Company/Industry shall either be a public sector undertaking or a public limited undertaking or a private concern whose annual turn-over during the last two years exceeds Rs. 5 crores.

(iii) Candidates must submit the sponsorship certificate duly signed by the Head of the Institution/Organization on the prescribed Proforma at the time of counselling.

4. Out of 18 approved seats, 9 seats shall be filled up from sponsored officials of Ministry/ Government / Semi-Government organizations from India, according to merit.

5. For remaining 9 seats, candidates with valid GATE score in the above mentioned branches shall be preferred and admitted according to merit.

6. An entrance examination shall be conducted by NERIWALM (NERIWALM-EE-2021) for the candidates who do not have either valid GATE score or official sponsorship. The residual vacant seats arising out of Clause 4 and Clause 5, shall be filled up from the merit list of the Entrance Examination.

7. Statutory Reservation and Relaxation Policy shall be followed as per Government of India Rules.

9. The selected candidates must have to produce the original testimonials and certificates at the time of counselling.

Admissions and studentship and related matters are governed by the ASTU, Guwahati ordinances/regulations/rules/norms framed/amended/modified and in vogue from time to time. Accordingly, the admission for session 2020-2021 will be as per new regulations in force.

## SCHOLARSHIP

(i) **For Sponsored Candidates:** No fellowship or financial assistance of any sort will be provided by the NERIWALM.

(ii) **For GATE qualified Fresh Graduates:** Seats shall be filled through GATE qualified fresh graduates. These candidates may be considered for assistantship in accordance with regulations/ordinances/rules of ASTU, Guwahati.

(iii) The GATE qualified candidates admitted to the AICTE approved courses are eligible for Scholarship/Stipend as per the AICTE norms, and shall be required to apply to the AICTE portal. The Institute decision in this regard shall be treated as final. The students can avail the scholarship facilities from the respective states.

However, irrespective of the source of scholarship/stipend, a **student must attend at least 75% of classes in each course in which he/she has registered, failing which the scholarship/stipend may be terminated. Students cannot avail multiple scholarship/stipend from any other sources.**

#### **NOMINATED CANDIDATES**

Eligible candidates officially nominated through various government agencies can be admitted provided the sponsored candidates give an undertaking that all the expenses including the teaching cost will be paid in advance. Such applications should come through the head of the Department/ Organization / competent authority to **Director, NERIWALM, Tezpur**. The NERIWALM, Tezpur will communicate the amount of advance payment to be made to this effect.

Interested candidates may apply in duly filled in prescribed Application Form by downloading from institute website [www.neriwalm.gov.in](http://www.neriwalm.gov.in) and depositing application fee of Rs. 300/- per candidate through a Demand Draft drawn in favour of North Eastern Regional Institute of water and Land Management (NERIWALM), payable at Tezpur on or before last date of submission of the application by **Registered/Speed Post/E-mail ([mtechadmission.neriwalm@gmail.com](mailto:mtechadmission.neriwalm@gmail.com))**. In case of account deposit, the receipt must be submitted along with the application.

### ABOUT TEZPUR

Tezpur, a quiet town of moderate size in the district of Sonitpur (Assam), is located on the banks of the Brahmaputra. It is about 180 km east of Guwahati city. Tezpur is also well connected by road, being located near the NH 52. The Tezpur town (Latitude 26.65°N and Longitude 92.79° E) is 64 m above mean sea level. The temperature ranges from 7 °C to 20 °C in winter (October to March) and from 25 °C to 39 °C in summer (April to September). The average annual rainfall is 1800 mm and bulk of it occurs from middle of June to October.

Apart from NERIWALM, which is situated in a 8 hectare campus, Tezpur is an important centre of academic activity. It has Tezpur University, LGB Regional Institute of Mental Health, Tezpur Medical College and Hospital, Indian Statistical Institute, etc. along with an important Army and Airforce base.

The Institute campus is 10 kms from Tezpur Airport, 7 kms from the Tezpur Railway Station and is 3 kms from the Roadways Bus Station.

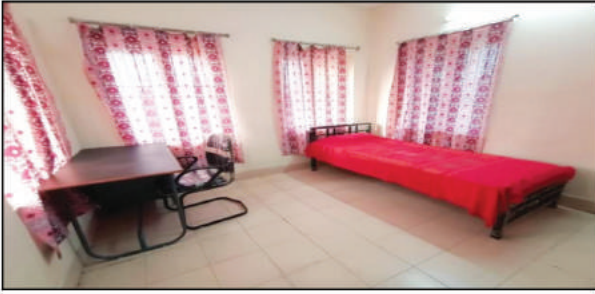

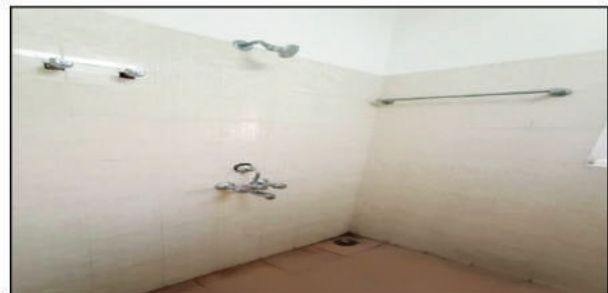
