**MEMORANDUM OF UNDERSTANDING BETWEEN NORTH-EASTERN REGIONAL INSTITUTE OF WATER AND LAND MANAGEMENT (NERIWALM), TEZPUR AND ASSAM AGRICULTURAL UNIVERSITY (AAU), JORHAT**

This Memorandum of Understanding (MoU) is signed on seventeen Mar. two thousand sixteen (Date in words) between North Eastern Regional Institute of Water and land Management (NERIWALM), Tezpur, an Institute registered under the Society Registration Act XXI, 1860 under Ministry of Water Resource, RD & GR, Govt. of India having its establishment at Tezpur (hereinafter referred to NERIWALM which expression shall include its representative, successors and assigns) of the first part;

AND

Assam Agricultural University, Jorhat, a premier academic and research organization of the North Eastern Region (NER) of India having its headquarter at Jorhat, Assam (hereinafter referred to AAU which expression shall include its representative, successors and assigns) of the other part.

**PREAMBLE**

**WHEREAS**, NERIWALM is engaged in conducting capacity building activities and R & D works on in the field of water and land resources management of NER.

**WHEREAS**, AAU is engaged in teaching research and extension of Agriculture as a whole in the state Assam

**AND**

**WHEREAS**, both NERIWALM and AAU, now

- (i) recognizing the importance of capacity building activity and research & development works in the areas of water and land management in agricultural in Assam,
- (ii) appreciating the need of promotion of different water management technologies developed by AAU through demonstration, active research in participatory mode with farms,
- (iii) desiring to collaborate their efforts by pooling their expertise and resources.

**INTEND** to conduct programmes in collaborative mode for enhancing the capacity of the farmers in adoption of suitable water management technologies with focus on imparting training, field demonstration and researches in irrigated command areas of Assam.

NOW, THEREFORE, in consideration of mutual made herein and of good and valuable consideration, receipt and sufficiency of which both NERIWALM and AAU hereby acknowledge. NERIWALM and AAU hereby agree as under:

**SCOPE of MoU :**

**1. SHARING OF EXPERTISES :**

The two institutions will share their expertise for the proposed programmes.

**2. JOINT TRAINING - CONFERENCES/WORKSHOPS :**

Training programme will be organized jointly by both the organizations from time to time for the selected farmers for enhancing their capacity for adoption of technologies. Conferences and workshops may also be organized involving all other stake holders for sharing and reviewing the experiences.

**3. JOINT RESEARCH AND DEVELOPMENT PROGRAMME:**

Research & Development works will also be proposed on mutually agreed aspects with financial assistance of different organization and ministries etc.

**4. LOCATION OF ACTIVITIES :**

Irrigated command areas of different irrigation scheme of Assam with involvement of the KVKs under AAU wherever felt necessary.

**5. SHARING OF INFORMATION :**

Both Institutions agree to share information on water and land management technologies.

**6. PUBLICATION OF DATA, INFORMATION/RESULT OF THE JOINT PROGRAMME :**

Both the institution will enjoy right to disseminate and publish the information and data of the activities conducted jointly.

**7. FINANCIAL LIABILITY :**

Training programme will be the part of NERIWALM Annual Training programme and shall be conducted within its budgetary provision. Agricultural inputs, Irrigations water measuring devices if necessary will be provided by NERIWALM. Expenditures related to tour in connection with visit to project site, taking part in training, workshop, conferences etc. will be responsibility of the Scientist/staff of concerned organizations
