# TERMS AND CONDITIONS FOR MAINTENANCE AND UPKEEPING OF LANDSCAPING AND HORTICULTURAL SITES OF NERIWALM CAMPUS

# 1. Location of the work:

The work is to be carried out at six different locations in the NERIWALM campus located at Dolabari, Tezpur- 784027(Assam).

#### 2. Period of contract:

The annual maintenance works will be allotted initially for a period of **one year**. The work can be extended for a further period of one year and more on mutual understanding of both the parties provided the authority is satisfied by the work performance. In such extension, if considered, 10% enhancement will be provided per year over and above the previous rate. The date of commencement of the work shall be notified after observing all formalities. The work shall be carried out 6 (six) days a week.

#### 3. Facilities offered:

The Institute shall provide water for irrigation and electricity for operating machineries/tools free of cost to the contractor/service provider from the possible nearest points for execution of the work.

#### 4. Nature of works:

**i.** Maintenance activities will have to be carried out as per the "Schedule of works" under the supervision/guidance of concerned Officer In-charge and to the satisfaction of the Director, NERIWALM.

**ii.** Maintenance of Horticultural activities/landscaping (lawns, trees, shrubs, seasonal flower beds, creepers, potted plants, ground cover etc.) shall include cost and supply of labours, fertilizers & manures, seeds/seedlings of seasonal flowers and shrubs & trees, fungicides, watering, cleaning of beds, mowing, weeding, hoeing, watering, fine dressing, pruning, earthling up etc.

iii. The rate quoted by the contractor should be inclusive of all taxes, duties and transportation etc.

**iv.** Any delay or damage caused to the planting materials/landscaped areas and Institute's properties by the contractor during the execution of the works shall be replaced/repaired by the contractor at this own cost and risk.

**5. Security Deposit:** Security Deposit at the rate 10% of the ordered amount in the form of Demand Draft drawn in favour of Director, NERIWALM should be deposited before taking up the maintenance works. The earnest money will be adjusted with the security deposit.

#### 6. Terms of payment:

**i.** The payment shall be made on the basis of actual quantum of work (whole or part of any item) executed, accepted and certified by the concerned Officer In-charge and to the satisfaction of the Director, NERIWALM. Payments will be made on monthly basis (before 10<sup>th</sup> of every month) on submission of bill in duplicate addressed to the Director, NERIWALM, Tezpur within first week of each month.

ii. No advance payment shall be made under any circumstances.

iii. Income tax, sales tax and other tax applicable, if any, shall be deducted at source from the contractor's monthly bill.

#### 7. Engagement of Labour:

i. The contractor shall not employ a person who has not completed 15 years of age.

**ii.** A minimum of 4 (four) regular labours (at least 3 unskilled and 1 semi-skilled labours) should be engaged six days a week for the maintenance work. In case of exigencies, NERIWALM (shall be referred as the Institute) may ask to offer service at times even on Sundays and holidays. The Institute may issue advance intimation before 24 hours for the purpose. No extra payment will be made for exigencies works.

**iii.** An Attendance Register shall be maintained by the Contractor for the labours engaged by him/her which will be examined/checked by the Officer, In-charge, NERIWALM as and when felt necessary.

**iv.** Payments to the workers should be made by the contractor as per the minimum wages notified by the Govt. of India within  $10^{\text{th}}$  day of every month. The payment register should be made available to the Institute for necessary checking every month after disbursement of wages.

**iii.** The contractor should ensure that the labours engaged for work should be disciplined, well mannered, obedient and does not roam around the campus unnecessarily both during duty hours and during non-duty hours.

iv. If any misconduct of the labour is reported, the contractor should immediately replace him.

#### 8. Schedule & Quantities of items:

The quantities shown in the "Schedule of items" are "Estimated Quantities" only. The quantities of different items may vary depending upon the various conditions/situations during execution of the work and payment will be made as per actual measurement.

**9.** Implements such as scissors/hedge cutter, lawn mower, dao, sickle, spade, khanti, watering pipe, ladder etc. required for the work will have to be procured or made available by the contractor at his own risk and cost.

**10.** The consumables items such as manure & fertilizers, seeds & seedlings of seasonal flower/trees and shrubs (as when necessary) pesticides/fungicides, cow-dung/FYM, bamboo jharu, bamboo, bamboo basket, rope etc. will have to be supplied by the contractor as and when needed t his own risk and cost.

**11.** The garbages collected from field should be disposed off immediately in the low lying areas outside the campus of the Institute. No litters/garbages should be allowed to be accumulated in the lawns any places within the campus at any point of time.

**12.** The Director, NERIWALM reserves the right to cancel the agreement/work allotted to the contractor at any time without assigning any reason thereof and the decision of the Director will be binding on the contractor.

**13.** An agreement has to be signed by the Contractor with the Institute before undertaking the work.

**14.** Any other terms & conditions which is not covered above, the Director, NERIWALM will be the sole authority to dispose the matter judiciously and amicably.

The tender should be accompanied with the following DOCUMENTS without which the tender will be summarily rejected.

- 1. Earnest money amounting to Rs 8,200.00 (Rupees eight thousand two hundred) only in the form of a Demand Draft / Banker's Cheque drawn in favour of the Director, NERIWALM, Tezpur.
- 2. Attested copies of **up to date** Registration Certificate, copy of GRN number under VAT rules, PAN Card, Labour License, experience certificate, PF registration, ESIC registration, etc. as per applicable.
- 3. The rate should be <u>legibly written both in figure and in words</u>. Any correction on the rate should be properly initialed. No request for change of rate will be entertained after opening of the tender.
- 4. The contractor will strictly abide by the necessary labour rules imposed upon by the Central Govt., Deptt. of Labour, from time to time for the labours engaged by him. Payments to the labours should be made by the contractor as per the minimum wages approved by the govt. The quoted rate should also include service tax and other taxes if applicable with provision for PF & ESIC contribution of the labours.
- 5. The contractor should provide the necessary risk to the labours for any type of accident that may arise at the work site or within the campus.
- 6. Taxes such as Income Tax, VAT, etc will be deducted at source and deposited in the Govt's account. The party will be made available with the receipt of tax deposited certificate in due course.
- 7. The materials to be used at the work site should be good and of reputed brand/manufacture. The quality of the materials to be used should be checked/examined and got approved before using it for the work.
