TERMS & CONDITIONS

1. The tender should be accompanied with Earnest Money of Rs 3,025.00 (Rupees three thousand twenty five) only in the form of Demand Draft/Banker's Cheque drawn in favour of Director, NERIWALM, Dolabari, Tezpur without which the tender will be summarily rejected.
2. Self attested Uptodate Contractor's Registration Certificate of appropriate class, Labour Licence, Income Tax Clearance Certificate, PAN Card, GST Registration and Experience Certificate, etc should be submitted alongwith the tender papers.
3. The rates should be legibly written both in figure and in words. Any correction should be authenticated with proper initial.
4. No request for change of rate will be entertained after opening of the tenders.
5. For items such as air conditioners, necessary brochures, write ups and warranty card with servicing details during warranty period should be submitted after completion of the work.
6. 90% payment will be released after completion of the work and the remaining 10% will be retained as Security Deposit for a period of 01 (one) year.
7. As the work is urgent in nature, the work should be completed within the stipulated time. No further extension of time will be granted unless a very strong and satisfactory reason is given.
8. The Contractor should provide necessary risk to the labours from any type of accident that may arise at the work site or within the campus.
9. The materials to be used by the contractor should be got approved from the authority before using the same for the work.
10. Any other clause not covered above, the contractor will be liable to abide by the direction/instruction of the Director, NERIWALM in the interest of the Institute.
11. The Director, NERIWALM reserves the right to accept/reject any or all tenders without assigning any reason thereof and there is no binding on the Director to accept the lowest rate.
