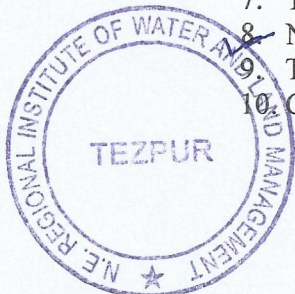

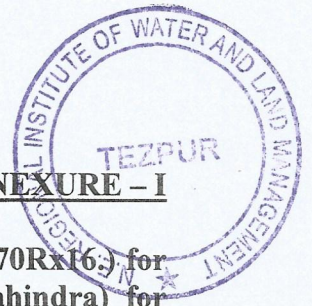

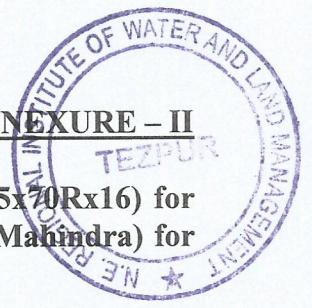

TERMS AND CONDITIONS

1. The sealed envelope containing the quotation (Annexure-I & Annexure-II) should be superscribed, as “Quotation for supply of tyres” and addressed to the Director, NERIWALM, Dolabari, P.O. Kaliabhomora, Tezpur- 784027 (Assam).
(The rate should be indicated in both figures and words. Corrections/overwriting, if any, in the quotation shall be made by initialling, dating and re-writing).
2. The rate quoted shall be firm and final. The price shall be inclusive of transportation i.e., F.O.R. NERIWALM, Tezpur. Any damage occurred during transit should be borne by the agency itself.
3. Authorised dealership certificates and updated VAT Clearance certificates are to be enclosed along with quotation.
4. TIN/PAN number of the firm/party must be mentioned on the quotation.
5. Make and Model number of the proposed tyres must be mentioned and as per specification while quoting the rates. Quotation will be liable for rejection if the rates are quoted without mentioning make and model number of the proposed tyres.
6. Each page of the Quotation document (Annexure-I & Annexure-II) are to be properly signed.
7. Guarantee/Warranty from the date of successful testing (As per the Company’s manual) is to be mentioned.
8. The delivery shall have to be made within 04(four) weeks from the date of issue of supply order.
9. Normally, the lowest rates quoted will be accepted but the Director, NERIWALM reserves the right to reject any or all the quotations without assigning any reasons.
10. The payment will be made after full supply in good condition as per specification.
11. Validity of the quotation should be for a period of minimum (03)three months from the date of opening.
12. All duties taxes (except sales tax and octroi) and other levies payable by the supplier/contractor under the contract should be included in the price/rate. Octroi exemption certificate if necessary will be issued by their office.
13. VAT will be deducted at source and certificate will be issued in due course.
