Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and

its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. Bidders are bound to accept the orders accordingly.

1. The bidder must submit the copy of GST Registration and latest 06 month GST return file documents , P AN. card, ATC certificate other wise the bid will be rejected.

- 2. Buyer may reject the product if not found as per requirement.

- 4. Defective product not acceptable. Seller have to replace with new product only.
- 5. Bidder Declaration regarding Blacklisting.

- 12. Seller has to deliver the goods as well as fitting and commissioning within stipulated time.
