- **2.1.2** "Bidder" means the individual or firm or corporate body who participates in the tender and submits its bid.
- **2.1.3** "Letter of Intent (LOI)" means the communication of the intention of the Employer to the Bidder to place the Work Order for the former's offered work/services.
- **2.1.4** "Purchase/Work Order (PO)" means the order placed by the Employer on the Contractor duly signed by the Employer's authorized representative to purchase certain goods & services from the vendor/contractor.
- **2.1.5** "Contract Price" means considerations payable to the supplier/contractor as stipulated in the Purchase or Work Order for performance of specified contractual obligations.



#### 2.2 BIDDER TO BEAR COST OF PURCHASE OF TENDER

The Bidder shall bear all costs associated with the preparation and submission of the bid. The Purchaser in any case will not be responsible or liable for these costs regardless or the conduct of the bidding process.

#### 2.3: EXTENSION OF TIME

In order to give prospective bidders required time in which to take the amendments into action in preparing their bid, the Employer may at its discretion extend the deadline for submission of bid suitably.

#### 2.4: BID PRICE

## 2.9: EVALUATION OF TENDERS
