

INSTRUCTIONS TO BIDDERS

2. : INTRODUCTION (DEFINITIONS)

2.1.1 "Purchaser" means North Eastern Regional Institute of Water and Land Management (NERIWALM), Dolabari, Tezpur – 784027 (Assam).

2.1.2 "Bidder" means the individual or firm or corporate body who participates in the tender and submits its bid.

2.1.3 "Letter of Intent (LOI)" means the communication of the intention of the Purchaser to the Bidder to place the Purchaser Order/Work Order for the former's offered goods/services.

2.1.4 "Purchase/Work Order" means the order placed by the NERIWALM on the Contractor/Supplier duly signed by NERIWALM's authorized representative to purchase certain goods & services from the vendor/contractor.

2.1.5 "Contract Price" means considerations payable to the supplier/contractor as stipulated in the Purchase or Work Order for performance of specified contractual obligations.

2.1.6 "Contractor/Service Provider" means the bidder who will be awarded work under contract .

2.1.7 "Institute" means the NERIWALM authority.

2.2 : BIDDER TO BEAR COST OF PURCHASE OF TENDER

The Bidder shall bear all costs associated with the preparation and submission of the bid. NERIWALM in no case will be responsible or liable for these costs regardless for the conduct of the bidding process.

2.3 : AMENDMENT TO BID DOCUMENTS

2.3.1 At any time, prior to the date of submission of bids, NERIWALM may for any reason, whether at its own initiative or in response to a clarification requested by a prospective bidder, modify the bid documents by amendments.

2.4 : EXTENSION OF TIME

2.5 : BID PRICE

2.7: BID SECURITY

2.7.1. The Bid Security of the unsuccessful bidder will be discharged/ returned as promptly as possible

2.7.2. The successful bidder's bid security will be discharged upon the bidder's submission of the Performance Guarantee/Security.

2.7.3. The bid security may be forfeited under the following circumstances:-

a) If a bidder withdraws his bid during the period of bid validity specified by the bidder on the bid form.

b) In case the successful bidder fails to submit the Performance Guarantee/Security within the prescribed time.

2.7.4. No interest is payable on EMD.

2.7.5. In case of inadequacy or non-submission of prescribed EMD, the tender shall be deemed to be disqualified and shall be summarily rejected in the technical evaluation.

2.8 : VALIDITY PERIOD OF BID

Bid shall remain valid for 120 days after the date of bid opening. The bid valid for a shorter period shall be rejected by the NERIWALM as non-responsive.

2.9: CLARIFICATION OF BIDS

2.9.1. The NERIWALM does not bind itself to accept the lowest tender or any tender(s) and reserves the right to accept the whole or any part of the tender and altering the quantities offered and tenderer shall abide by the decision of NERIWALM.

2.10 : NERIWALM'S RIGHT TO ACCEPT ANY BID AND TO REJECT ANY OR ALL BIDS

GENERAL (COMMERCIAL) CONDITIONS OF THE CONTRACT

3.1 : PRICE APPLICABILITY

Prices in the Purchase Order/Work Order shall remain valid for the Contract Period of 02(two) years from the date of signing of formal agreement. However, the contract may be renewed on mutual understanding for a further period provided the performance of the the Contractor/Supplier is found to be satisfactory. If the service is found un-satisfactory NERIWALM can cancel the work with 01(one) month prior notice which will be binding on the Contractor/Supplier.

3.2 : PERFORMANCE SECURITY

3.2.1. Within 10 days of the Supplier's/Contractor's receipt of Letter of Intent LOI/WO, the Supplier/Contractor shall furnish a Performance Security for an amount as mentioned in the General Terms & Conditions(Section-5) in the form of Draft/Banker's Cheque/FD/Bank Guarantee issued by a schedule Bank from its branch payable at Tezpur, Assam.

3.3 : CHANGE ORDERS

3.3.1 The NERIWALM may at any time by written order given to the Supplier/Contractor/Firm make changes within the general scope of the contract in any

3.4 SUB-LETTING

The Bidder cannot assign or transfer and sub-contract its interest/ obligations under the contract without prior written permission of the NERIWALM.

3.5 ARBITRATION

3.5.1 In the event of any dispute arising between NERIWALM and the Supplier/Contractor, in any matter covered by this contract or arising directly or indirectly therefrom or connected or concerned with the said contract in any manner of the implementation of any terms and conditions of the said contract, the matter shall be referred to the Director, NERIWALM who may himself act as sole arbitrator or may name as sole arbitrator an officer of NERIWALM notwithstanding the fact that such officer has been directly or indirectly associated with this contract and the provisions of the Indian Arbitration Conciliation Act, 1996 shall apply to such arbitration. The supplier expressly agrees that the arbitration proceedings shall be held Tezpur.

3.5.2 The proceedings of arbitration shall be in English language:

3.5.3 In case any supplier wants to take the dispute to a court of law after arbitration award as aforesaid, it is clearly understood that only courts in Tezpur and Guwahati shall have the Jurisdiction.

3.5.4 In case of Public Sector Undertaking/Government Departments

In the event of any dispute or difference relating to the interpretation and application of the provisions of the contracts with any Public Sector Undertaking / Government Department, such dispute or difference shall be referred by either party for Arbitration to the sole Arbitrator in the Department of Public Enterprises to be nominated by the Secretary to the Government of India in-charge of the Department of Public Enterprises. The Arbitration and Conciliation Act, 1996 shall not be applicable to arbitration under this clause. The award of the Arbitrator shall be binding upon the parties to the dispute, provided, however, any party aggrieved by such award may make a further reference for setting aside or revision of the award to the Law Secretary, Department of Legal Affairs, Ministry of Law & Justice, Government of India. Upon such reference, the dispute shall be decided by the Law Secretary or the Special Secretary / Additional Secretary, when so authorized by the Law Secretary, whose decision shall bind the Parties finally and conclusively. The Parties to the dispute will share equally the cost of arbitration as intimated by the Arbitrator.

3.6 APPLICABLE LAWS

This contract shall be interpreted, construed and governed by the laws of the Republic of India and the parties hereby submit to the exclusive jurisdiction of the Court at Tezpur and Guwahati having jurisdiction in

appeal there from. Any dispute in relation to the contract shall be submitted to the appropriate Court of the Republic of India for determination. The parties to the contract shall continue to fulfill their respective obligations under the contract during the currency of the contract pending the final decision of the Court.

3.7 GENERAL LIEN

Whenever under this contract any sum of money is recoverable from and payable by the Supplier/Contractor, the NERIWALM shall be entitled to recover such sum by appropriating in part or in whole the Performance Security/Security Deposit of the Supplier/Contractor. In the event of the Security being insufficient or if no security has been taken from the Supplier, the balance or the total sum recoverable, as may be, shall be deducted from any sum due to the Supplier or which at any time thereafter may become due to the Supplier under this or any other contract with the Company. Should this sum be not sufficient to cover the full amount recoverable, the Supplier shall pay to the Company on demand the remaining balance due.

3.8 FORCE MAJEURE

At any time, during the continuance of this contract, the performance in whole or in part by either party under obligation as per this contract is prevented or delayed by reasons of any war or hostility, act of the public enemy, civil commotion, sabotage, fire, flood, explosion, epidemic, quarantine restrictions, strike, lockout or acts of God (hereinafter referred to "eventuality"), provided notice of happening of any such eventuality is given by either party to the other within 21 days of the date of occurrence thereof, neither party shall be reason of such an "eventuality" be entitled to terminate this contract nor shall either party have any claim or damages against the other in respect of such non-performance or delay in performance and deliveries under the contract. The contract shall be resumed as soon as practicable after such "eventuality" has come to an end or ceased to exist. In case of any dispute, the decision of Director, NERIWALM, shall be final and conclusive, provided further that if the performance in whole or part of any obligation under this contract is prevented or delayed by reason of any such eventuality for a period exceeding 60 days, either party may at its option, terminate the contract. Provided also that if the contract is terminated under this clause the NERIWALM shall be at liberty to take over from the Supplier/Contractor at a price to be fixed by the NERIWALM, which shall be final, all unused, undamaged and acceptable materials, bought out components and other stores in the course of manufacture which may be in the possession of the Supplier at the time of such termination, or such portion thereof as the NERIWALM may deem fit except such material, as the Supplier/Contractor may, with the concurrence of the NERIWALM, elect to retain.

3.9 TERMINATION FOR INSOLVENCY

The NERIWALM may at any time terminate the Contract by giving written notice to the Supplier/Contractor, without compensation to the supplier/contractor if the supplier becomes bankrupt or otherwise insolvent as declared by the competent court provided that such termination will not prejudice or effect any right of action or remedy which has accrued or will accrue thereafter to the purchaser.

In case of any damage caused to the installation due to negligence, carelessness or inefficiency of the labours/manpower/staff engaged by the Contractor/Service Provider, it shall be responsibility of the Contractor to make good the loss. SECTION-5

5.1 : GENERAL TERMS & CONDITIONS:

5.1(A): The estimated value of requirement of Labour/Man power for initial 01(One) year is Rs 10,00,000.00 (Rupees Ten Lakhs) only. NERIWALM has no routine requirement for Labour/Man power to be outsourced. Separate work order shall be placed to the empanelled contractor(s) as and when labour/Man power is required showing the number of man days, category of labour/ Man power, period of engagement, etc. The concerned contractor shall raise the bill to the Director, NERIWALM, Dolabari, Tezpur(Pin-784027) after satisfactory completion of the supply as per approved rates of wages of labours, Contractor's Agency charge and other statutory parameters.

1 : All duties, taxes and other levies payable under the contract or for any other cause shall include in the Agency Charge.

2 : All expenditure whatsoever for the contractor's labours/manpower engaged for the works in NERIWALM shall be borne by the contractor. NERIWALM will not be responsible for any disputes/problems arising out of such situations for the labours/manpower engaged by the contractor. It should further be noted that in the case of any damage or loss incurred by the Institute due to the negligence/misdeeds of the labours/manpower engaged by him, the cost of such damage/loss will have to be borne by the contractor.

3: The contractor will strictly abide the labour Rules imposed upon him by the Govt Labour Department from time to time for the labours/manpower engaged by him for the works of NERIWALM. The contractor should furnish the necessary documents, papers issued by the appropriate competent authority. The contractor shall be liable to undergo any disciplinary actions of the Labour Department or any authority for any discrepancies or disputes arising out of the labours/manpower engaged for the work. The contractor is to maintain the up to date register, other records pertaining to payment and attendance which should be produced to the office for verifications and when called/asked for. The contractor should provide necessary risk to the labours/manpower for any type of accident/eventuality arising at the work site , within the campus or to and from their home.

4: The contractor shall submit a complete list and deployment report of his authorised labours/manpower to the office as when engaged . Necessary Gate Pass, Identity Cards of the labours/workers shall be issued by the contractor for counter signature by NERIWALM. The contractor is responsible to acquire all necessary Passes from the District Authority during restriction imposed by the District Administration or any authority. 5: The labour/manpower engaged by the contractor will have to well disciplined, well mannered and should not be alcoholic/drugs addicted.

6: Institute will not provide any accommodation for the contactor's labour/manpower.

7: Any other clause not covered in the contract or bid, the contractor will be liable to abide by the discretion of the Director, NERIWALM for proper execution of the works in the interest of NERIWALM.

5.1 : EXPECTED CATEGORY OF LABOUR/MANPOWER FORCE:

(a) Highly skilled Labour/manpower :

(For general/ Electrical/Agriculture/ Office related works): The labour/manpower shall have the requisite qualification and certificate/ Licence issued from appropriate authority.

(b) Skilled Labour/manpower :

(For general/ Electrical/Agriculture related works) : For Electrical work, operation of machine, driving of vehicle, office work and similar nature of works, the labour/ manpower shall have the requisite certificate/ Licence issued from appropriate authority.

(c) Semi -skilled labour /Clerical labour :

(For general/ Electrical/Agriculture related works): For Electrical work, operation of machine, office work, and similar nature of works, the labour/ manpower shall have the requisite certificate/ Licence issued from appropriate authority ...

(d) Unskilled labour/manpower :

(For general/ Electrical/Agriculture related works): The labour/manpower shall have the basic knowledge of the works for which shall be engaged

5.3 : PERFORMANCE SECURITY

1: Within 10 days of the Supplier's/Contractor's receipt of Letter of Intent LOI/WO, the Supplier/Contractor shall furnish a Performance Security for an amount of Rs 20,000.00 (Rupees Twenty thousand) only in the form of Draft/Banker's Cheque/FD/Bank Guarantee issued by a schedule Bank from its branch payable at Tezpur, Assam.

2 : The proceeds of the Performance Guarantee/Security shall be payable to the NERIWALM as compensation for any loss resulting from the Supplier/Contractor/Firm's failure to complete its obligations under the contract.

3: The Performance Security will be discharged/returned by NERIWALM after completion of the supplier's/contractor's obligations including any warranty obligations under the contract.

5.4: ACCIDENT, INSURANCE, COMPENSATION, ETC:

1. The entire labour/work force of the Contractor/Service Provider will have to be covered under insurance against any kind of accident or eventuality and NERIWALM will not be liable for payment of any compensation on that account. During the execution of work, the Contactor shall follow all standard norms of safety measures / precautions to avoid the accident / damages to man, machineries and building. Non adherence of this clause, may invite payment of Fine/Compensation and face punishment as decided by the Competent Authority of NERIWALM or Central/State Labour Authority. NERIWALM is not liable to pay anything against accident, any eventuality, insurance, compensation etc.

5.5 : BASIC TERMS & CONDITIONS

- In the event of the Agency/ Contractor's failure to execute the work entrusted to it under this Agreement satisfactorily, NERIWALM shall make alternative arrangement to do it and the difference of cost incurred by NERIWALM thereby shall be recovered from the Agency/ Contractor's unpaid bills and Contractor's Security deposit. Besides penalty as decided by NERIWALM shall also be levied and recovered.
- 2. All taxes, duties, levies etc. imposed by the State, Central Government and Local Bodies in connection with this contract in force at the time of submission of offer shall be done by the Agency/Contractor.
- 3. The rates to be offered/ given to the workers of different category should be as per the approved rate of Govt. of India, Ministry of Labour and Employment prevailing at that particular time. Payment should be invariably made under DBT mode.
- 4. Revision of Minimum Wages as per Govt. notification will be considered with its retrospective effect subject to submission of application along with notification by the Agency/Contractor.
- 5. If and whenever any of the Agency/Contractor's employee shall be found guilty of any misconduct or be incompetent or insufficiently qualified or negligent in the performance of their duties or theft and is rendered undesirable for administration or any other reason for such person/persons to be employed in the works, the Agency/Contractor if so directed by the competent authority, shall remove such person/persons from employment. Any person/persons so removed from the works shall not again be employed in connection with the without the written permission of the competent authority of NERIWALM.
- 6. Labour/workman supplied by the contractor will be engaged at any level of building, infrastructure, post, trees etc above and below the ground level.

- 7. The contractor shall be responsible for fulfilling all his obligations towards the person(s) deployed under the labour laws and fulfilling the requirements of all statutory provisions of relevant enactments namely Minimum Wages Act, Workmen Compensation Act, the Contact Labour (Regulation and Abolition) Act, EPF Act, Payment of Wages Act, ESI Act, Bonus Act, Maternity Benefits Act, or other labour rule, regulation applicable and amended from time to time. The contractor shall be responsible for the deposit of employee's and employer's share of statutory contribution to the ESI/EPF, EDLI, if applicable at his own level and maintenance of such record as per rule. The contractor shall be responsible for linking of UAN's for all the person deployed and complete all the necessary formalities as required under EPF/ESI act.
- 8. The working time is preferably 8.00AM to 1.00PM and from 2.00 PM to 5.00PM or as directed by the institute.
- 9. The contract will be valid for a period of 01(one) year with provision of extension for a further period of one year on mutual understanding of both the parties provided, the performance of the party found to be satisfactory.
- 10. Contractor's Service Charge and GST, EPF, ESIC as applicable should show separately in the bill.
- 11. No request for change of Contractor's charge will be entertained during the contract period .
- 12. The contractor should provide necessary risk to the labour/manpower from any type of accident that may arise at the worksite or within the campus. First Aid Box should be made available in the Security Office at all time by the labour supplier for immediate medical requirement.
- 13. The implements required for carrying out different nature of work by the labour/manpower are to be arranged by the labour/manpower supplier at his own risk and cost. NERIWALM will not make any payment whatsoever against procurement of implements, etc.
- 14. Payment will be made as per actuals. The working time is preferably form 8.00AM to 1.00 PM and from 2.00PM to 5.00PM or as directed by the institute. However during exigency arising out VIP visits, training, etc. the labour supplier should be able to supply labour/manpower within 24 hours.
- 15. The labour/manpower to be engaged should be above 18(eighteen) years of age.
- 16. A labour Attendance Register should be maintained by the labour/manpower supplier for recording daily attendance of workers in the prescribed format. The Attendance Register should be produced daily before the concerned authority for necessary inspection and signature.
- 17. Payment to the contractor/supplier will be released only after completion of the particular work for which the labour/manpower has been hired. However, NERIWALM desires that the contractor should clear the labour wages even though payment from NERIWALM is delayed.
- 18. Any other clause not covered above, the contractor will be liable to abide by the direction/instruction of Director, NERIWALM in the interest of the Institute.
