TERMS & CONDITIONS

- 1. The tender should be accompanied with Earnest Money of a Lumsum amount of ₹ 20,000.00 in the form of Bank Draft/Banker's Cheque in favour of Director, NERIWALM, Tezpur. Tenders without earnest money will summarily be rejected.
- 2. Earnest Money of the successful bidder will not be released and the same amount will be transferred as Performance Security.
- 3. Self attested uptodate Labour Licence, PAN Card, GST Registration, Experience Certificate, etc should be submitted alongwith the tender documents.
- 4. Labour Licence should clearly indicate the number of labour the supplier is authorized to engage at a given time for a particular work.
- 5. The tender will be valid for a period of 01(one) year with a provision of extension for a further period of one year on mutual understanding of both the parties provided that the performance of the party is found to be satisfactory.
- 6. The rates to be offered/given to the workers of different category should be as per the approved rate of Govt. of India, Ministry of Labour and Employment prevailing at that particular time. Payment should invariably be made under DBT mode. However, revision of rate will be effected by NERIWALM as and when the rates are revised from time to time.
- 7. Since, payment will be made as per Govt of India approved rates prevailing during the period, the bidders are to quote only the Agency Charge / Contractor's Profit in percentage basis. GST as applicable may be shown separately in percentage basis.
- 8. No request for change of rates will be entertained after opening of the tender.
- 9. The contractor should provide necessary risk to the labours from any type of accident that may arise at the work site or within the campus. First Aid Box should be made available in the Security Office at all time by the labour supplier for immediate medical requirement.
- 10. The implements required for carrying out different nature of works by the labours are to be arranged by the labour supplier at his own risk and cost. NERIWALM will not make any payment whatsoever against procurement of implements, etc.
- 11. Payment will be made as per actual. The working time is preferably from 8.00AM to 1.00 PM and from 2.00 PM to 5.00 PM or as directed by the institute.
- 12. Canvassing in any form is strictly prohibited. If anybody found doing so will be debarred from participating in the tender.
- 13. The Director, NERIWALM reserves the right to accept/reject any or all tenders without assigning any reason thereof and there is no binding on the Director to accept the lowest rate.
