TERMS & CONDITIONS

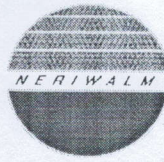
1. Sealed tenders are invited by the Director, NERIWALM, Tezpur from appropriate registered dealer/firms of repute for Supply & installation of Split Type Air Conditioners NERIWALM, Dolabari, Tezpur. The tender should be accompanied with Earnest Money equivalent to 2% of the quoted value in the form of Bank Draft/Banker's Cheque in favour of **Director, NERIWALM**, Tezpur. Tenders without earnest money will summarily be rejected.
2. Self attested upto-date Registration/Delership Certificate, PAN Card, GST Registration, should be submitted alongwith the tender documents.
3. Make and quality of the materials should be clearly mentioned where possible. Necessary brochures alongwith Technical Specifications and drawings etc should attached with the tender. If the party wishes they can inspect the site from 01.08.2019 to 10.08.2019.
4. The rates should be legibly written both in figure and in words. Any correction should be authenticated with proper initial. The quoted rates should be inclusive of GST as applicable.
5. No request for change of rates will be entertained after opening of the tender.
6. The selected bidder should deposit Performance Security for an amount of 10% (ten percent) of the Contract Value in the form of Account Payee DD/FDR/BG.
7. The work should be completed within the stipulated time. Extension may be considered only if a valid and tenable reason is given and accepted by the Competent Authority.
8. The contractor should provide necessary risk to the labours from any type of accident that may arise at the work site or within the campus. Labour Rules will be applicable on the Contractor/Party.
9. The materials to be used should be got approved from the authority before installation. It is the responsibility of the party to provide all allied materials required for installation and commissioning of the air conditioners.
10. Preference will be given to those brand whose Service Centre is available at Tezpur. The supplier/party should be ready to take up Annual Maintenance Contract of the ACs after the completion of the warranty/guarantee period. AMC proposal should be given alongwith the tender. The warranty/guarantee period of the product should be mentioned.
11. Payment will be made as per actual measurement of the work executed.
12. Any other clause not covered above, the supplier/party will be liable to abide by the direction/instruction of the Director, NERIWALM in the interest of the Institute.
13. The Director, NERIWALM reserves the right to accept/reject any or all tenders without assigning any reason thereof and there is no binding on the Director to accept the lowest rate.
