### Annexure-I

1. The tender should be accompanied with Earnest Money equivalent to 2% of the quoted value in the form of Bank Draft/Banker's Cheque in favour of **The Director, NERIWALM, Tezpur.** Tenders without earnest money will summarily be rejected.
2. Self attested uptodate Authorised Dealership Certificate, Labour Licence, PAN Card, GST Registration, Experience Certificate, etc should be submitted alongwith the tender documents.
3. The party should be a certified channel partner of Ministry of New Renewable Energy (MNRE), Govt of India for its off-grid solar programme and in this regard self attested document should be submitted.
4. The bidder must have successfully executed solar projects under the State/Central nodal agency as per MNRE scheme/program. Must have sufficient experience of execution of similar nature of works.
5. Make and quality of the materials should be clearly mentioned. Necessary samples, brochure, working manual, etc should be made available wherever possible. The materials to be used should be got approved before using the same at work.
6. After sale maintenance proposal should also be indicated clearly and submitted with the tender after the completion of the warranty period.
7. The rates should be legibly written both in figure and in words. Any correction should be authenticated with proper initial. GST as applicable should be shown separately.
8. No request for change of rates will be entertained after opening of the tender.
9. Successful bidder should deposit Performance Security of 10% of the ordered value of work in the form of DD/BC/BG to be drawn in favour of Director, NERIWALM, Tezpur.
10. Payment will be released after completion of the work and trial run atleast 10 days.
11. The work should be completed within the stipulated time. Extension will be granted only if a valid and tenable reason is given.
12. The contractor should provide necessary risk to the labours from any type of accident that may arise at the work site or within the campus.
13. The materials to be used by the contractor should be got approved from the authority before using the same for the work.
14. Payment will be made as per actual measurement of the work executed.
15. Any other clause not covered above, the contractor will be liable to abide by the direction/instruction of the Director, NERIWALM in the interest of the Institute.
