## Annexure-II

1. The tender should be accompanied with Earnest Money equivalent to $2 \%$ of the quoted value in the form of Bank Draft/Banker's Cheque in favour of The Director, NERIWALM, Tezpur. Tenders without earnest money will summarily be rejected.
2. Self attested uptodate Authorised Dealership Certificate, Labour Licence, PAN Card, GST Registration, Experience Certificate, etc should be submitted alongwith the tender documents.
3. The bidder must have successfully executed similar nature of work in State/Central/Autonomous Organization/Private. Must have sufficient experience of execution of similar nature of works. Certificate to this effect should be submitted.
4. Make and quality of the materials should be clearly mentioned. Necessary samples, brochure, working manual, etc should be made available wherever possible. The materials to be used should be got approved before using the same at work.
5. The party should be ready to enter into AMC for the equipment for not less than 05 years after completion of the warranty period. Proposal to this effect should be submitted with the tender without which the tender may be rejected.
6. The rates should be legibly written both in figure and in words. Any correction should be authenthicated with proper initial. GST as applicable should be shown separately.
7. No request for change of rates will be entertained after opening of the tender.
8. Successful bidder will have to deposit Performance Security of the value of $10 \%$ of the ordered value in the form of $\mathrm{DD} / \mathrm{BC} / \mathrm{BG}$ to be drawn in favour of Director, NERIWALM.
9. Payment will be released after completion of the work and Laboratory Test in regard to quality of water as specified.
10. The work should be completed within the stipulated time. Extension will be granted only if a valid and tenable reason is given.
