#### TERMS & CONDITIONS

- 1. The tender should be accompanied with Earnest Money equivalent to 2% of the quoted value in the form of Bank Draft/Banker's Cheque in favour of **Director**, **NERIWALM**, Tezpur. Tenders without earnest money will summarily be rejected.
- 2. Self attested upto-date Registration Certificate, PAN Card, GST Registration, should be submitted alongwith the tender documents.
- The work should preferably be executed by using mechanical excavator and should be completed within the specified date and time i.e. 15(fifteen) days from the date of signing of formal agreement.
- 4. The rates should be legibly written both in figure and in words. Any correction should be authenthicated with proper initial. The quoted rates should be inclusive of GST as applicable.
- 5. No request for change of rates will be entertained after opening of the tender.
- 6. The selected bidder should deposit Performance Security for an amount of 10% (ten percent) of the Contract Value in the form of Account Payee DD/FDR/BG.
- The contractor should provide necessary risk to the labours from any type of accident that may arise at the work site or within the campus. Labour Rules will be applicable on the Contractor/Party.
- 8. Payment will be made as per actual measurement of the work executed and accepted by the department.
- 9. Any other clause not covered above, the supplier/party will be liable to abide by the direction/instruction of the Director, NERIWALM in the interest of the Institute.
- 10. The Director, NERIWALM reserves the right to accept/reject any or all tenders without assigning any reason thereof and there is no binding on the Director to accept the lowest rate.
