## Terms and conditions for Vehicle with Driver:

- 1. The minimum duty hour for hired vehicles at a stretch is 14 hours
- 2. The Vehicle owner will have to provide 20 km free travel without POL charge (in local trip only), above which the POL charges will be entertained for payment.
- 3. -The claimed rates should be as per the approved rates which is inclusive of all charges, taxes, cost of all type of maintenance/repair of the vehicle, expenses of the Driver, etc and terms & conditions.
- 4. The initial Km. will be counted from the Head quarter/ respective station and mileage will be from duty point to duty point and no zero point will be allowed
