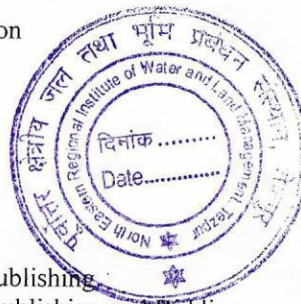

Tender fee and EMD amount exempted for NSIC/MSME units. Subject to submission of valid NSIC / MSME certificate.

Eligibility Criteria and Valid Documents to be submitted: Appropriate registered Firms/Contractors/Company/Individuals with Govt Department having experience in similar nature of work and having the following documents may participate in the bidding process as given below:-

1. Average Annual Financial Turnover during the last 3 years, ending 31st March 2022, should be at least Rs. 10.0 Lakhs.
2. Bidder should have experience of having successfully completed similar works during the last 3 years ending 31st March, 2022 should be either of the following:

Terms and conditions for Providing Vehicle Hiring Service on Call Basis with Driver and POL to NERIWALM, Dolabari, Tezpur, Assam (Pin-784027).

1. The successful bidder shall have to sign a contract agreement on Non-Judicial Stamp Paper along with deposit of Performance Security of Rs 10,000.00 by DD/BC/FD, from a scheduled Bank payable at Tezpur to be drawn in favour of Director, NERIWALM. The Performance Security will be retained for the whole contract period plus 03 (three) months and no interest is liable to be paid. The following documents duly attested are to be submitted at the time of signing the agreement.
 - (i) Self attested copy of GST registration certificate & PAN card.
 - (ii) Valid Registration Certificate of Travel Agency/ Trade Licence for running vehicles on hire basis.
 - (iii) Any other relevant documents pertaining to Business of Travel Agency.
 - (iv) Undertaking as per Format attached.
2. The service provider/owner should abide by the statutory requirement for running vehicle on providing hiring Contract with up to date and valid documents from competent authorities. The vehicle put for providing service on hire basis under NERIWALM shall be registered under commercial category with valid documents like Registration Certificate, Insurance, Road Permit and others under the liability of the service provider. Driver deputed with vehicle must possess the copies of the documents including the valid driving licence.
3. North Eastern Regional Institute of Water and Land Management (NERIWALM) under no circumstances shall be Liable to any loss/ damage of the vehicle for any kind of act which may cause injury/ damage/ death to vehicle or any other third party.
4. The quoted rates should be inclusive of GST, all other charges, taxes etc but excluding the parking fee & Toll fee. Parking fee & Toll fee shall be paid as per actual against submission of Bill with documentary evidence. The rates quoted by the successful bidder will be valid for not less 06(six) months.
5. The payment will be made against submission of Bill.
6. The service provider/owner should abide by the statutory requirement for running vehicle on providing hiring contract.
7. The vehicle may be required for any places of North Eastern States of India.
8. Any defects/trouble whatsoever of the vehicle should be taken care of instant by the owner/service provider and if required, the same must be replaced with another one at the cost and risk of the owner/service provider promptly within a short time.
9. The initial Km. will be counted from the Head quarter/ respective station and mileage will be from duty point to duty point and no zero point will be allowed.



10. Arrangement of food, accommodation, driver, fuel, parking facility of the vehicle including the expenses shall be the liability of the service provider/owner. Any expenditure of the vehicle and driver shall be the liability of the service provider/owner.
11. The hired vehicle must be in neat and clean condition & in excellent running conditions in all respect
12. The owner/ service provider shall have to entertain the request for placement of vehicle within Short notice.
13. The driver accompanying the vehicle should be sober and well-mannered with valid driving licence along with related documents of the vehicle issued from appropriate authority. The driver should be able to maintain journey /report/job card neatly. The Driver should have mobile phone facility to keep contact with the users and owner/service provider at the cost of the owner/ service provider.
14. No payment will be made if the owner/service provider failed to replace the vehicle in the event of any defect/trouble of the vehicle.

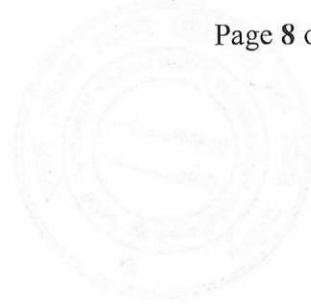
